## **RELEASE FOR EMERGENCY TREATMENT**

In the event that your pet should become ill, or is deemed by the El Dorado Pet Club to need medical care, we will attempt to contact the pet's current veterinarian as well as the emergency contact provided by the owner. If an emergency does not allow the time to do so prior to the administration of care, the owner hereby authorizes the El Dorado Pet Club (EDPC) to obtain medical attention for the pet from a qualified veterinarian we select, and to transport the pet to and from such veterinarian when EDPC deems such immediate medical care is important to the pet's health. The owner grants EDPC, its employees or agents, full power of decision making involving the medical care of the pet if the owner is not reachable. The owner agrees to be financially responsible for all costs of such treatment.
